
Mrs. Rappaport presented the Enrollment and ADA numbers. Mrs.
Rappaport noted that we are forecasting an enrollment drop in term 3
due to COVID-19. Mrs. Rappaport noted that we are forecasting target
enrollment for terms 4 and 5. Mrs. Rappaport noted that due to remote
instruction we are seeing a stabilization in ADA, rather than the
attendance swings we experienced before offering online instruction.

Revenue and Expenses




Mrs. Rappaport discussed the December 2021 Margin and Cash Flow.








December 2021 Margin and Cash Flow
