

DISTRICT CCMR PLAN

Goodwill Excel Center for Adults

Executive Summary

House Bill 3, a school reform and school finance law enacted by the Texas Legislature in 2019, requires that all school boards adopt and monitor College, Career, and Military Readiness (CCMR) Plans. These plans must set specific annual CCMR performance goals for the district, and for each campus, for five years. The board is to review progress toward the plan targets at least annually at a public meeting, with the progress reported on the school's website. Additionally, the plan must assign one district-level administrator, or employee from the regional service center, to oversee its implementation.

The accompanying 8 pages provide a preliminary CCMR Plan for the Goodwill Excel Center for Adults. The plan uses the measures of CCMR applicable to an adult high school. Under these measures, a graduate can demonstrate readiness in three ways:

- ✓ Completion of an industry certification program;
- \checkmark Enrollment in an institution of higher education; or
- \checkmark Achieving a significant income increase

The Plan sets a goal of increasing the overall percentage of Excel Center graduates demonstrating readiness from 17% to 45% by August 2025. At its campuses outside of the prison system, 75% of graduates are expected to show readiness by 2025. Campus-specific growth goals toward this target are included for each of Excel's five campuses.

NOTES:

- HB3 requires districts to set annual goals for aggregate student growth on the College, Career, and Military Readiness (CCMR) component of the Student Achievement domain of the accountability system described in Chapter 39 of the Texas Education Code. Under Chapter 39 accountability, graduates can demonstrate CCMR in any of eleven ways. See 2020 Accountability Manual, pp. 14-17.
- The Goodwill Excel Center for Adults is not under the Chapter 39 accountability system. The equivalent system for our school is the set of Adult High School Academic Indicators developed by the commissioner pursuant to Texas Education Code § 29.259, which currently reside within the Charter School Performance Frameworks. Under those indicators, graduates can demonstrate CCMR in any of three ways:

Indicator 1c: Completion of an industry certification program; Indicator 1d: Enrollment in an institution of higher education; or Indicator 1e: Significant income increase See 2019 Charter School Performance Framework Manual, p. 21.

In its references to "CCMR Criteria," this Plan uses those three indicators for adult high schools, rather than the eleven Chapter 39 accountability routes to CCMR.

- Additionally, HB3 directs districts to set annual goals for each student subgroup evaluated under the Closing the Gaps domain, if the group contains 30 or more students. The Adult High School Academic Indicators do not have a Closing the Gaps domain. However, this Plan uses the student subgroups from Chapter 39 accountability as district yearly targets, where the subgroups are applicable to our student population. At a campus level, the subgroups will rarely meet the minimum-size threshold.
- The campus plans for the Goodwill Excel Center for Adults vary widely between the three Austin-area campuses (Norwood, AYW, and South Austin) and the two campuses within correctional facilities (Lockhart and Billy Moore). Incarcerated students do not have the same access to certification programs while in prison, and often remain incarcerated after earning a diploma, so their ability to achieve the CCMR Criteria is significantly less. Currently, about 34% of the Excel Center's overall enrollment is at our two correctional campuses. The district goals reflect a combination of the Austin campuses and the correctional campuses.
